Location

Cherry Street Pier is located at 121 N. Columbus Blvd. Tables and tablespace will be made available inside the Pier following COVID-19 protocols on social distancing.

Paid parking lots are located across the street from Cherry Street Pier at the Holiday Inn Express. There is also a parking lot at Market Street and Columbus Boulevard. Limited street parking is also available

Fees

A 10x10' vending location will cost \$40 per day.

The Pier has six farmhouse style tables (10x4') that are available on a first-come, first-serve basis when requested on the application. Vendors are also welcome to bring their own tables and displays provided they fit within a 10'x10' footprint.

Fees are non-refundable and non-transferable without prior approval by DRWC. Cancellations must be reported promptly. Deposits are required in advance for the full amount. All markets will occur rain or shine with no rescheduling.

Guidelines

- The Pier has a strict 250-person capacity during the pandemic. This is monitored and controlled by security guards at CSP.
- Masks must be worn at all times by vendors and visitors
- All participants must sign a digital DRWC waiver
- While the Pier has a roof, it does not have heating or cooling. Please come prepared for the cold
- Free wifi is available for all vendors and guests
- Electric needs are considered on a case by case basis
- Amplification is prohibited
- Alcoholic beverages are prohibited.
- The sale and/or distribution of all food and beverages is prohibited.
- Vendor must check in with DRWC staff prior setting up their booth or table display
- DRWC will not provide storage of vending materials or goods
- DRWC is not responsible for vending materials or goods while in Cherry Street Pier.

COVID-19 Protocols

- Applicant and all participants must follow all State and City of Philadelphia COVID guidelines
- Vendors must wear a face covering at all times. Face coverings must cover both your mouth and nose.
- Vending areas will be set up 6ft apart

- Cherry Street Pier has hand sanitizing stations throughout the Pier, but we ask that you bring hand sanitizer for yourself and your customers
 - Vendors must disinfect hands after every customer.
- Please chalk or stickers to designate physically distant queue lines.
- We recommend bringing a physical barrier like sneeze guards and partitions.
- Clean and sanitize frequently touched surfaces including sales counters, tables, and products.
- **STAY HOME** if you are sick or if you've been in contact with a sick person.
